OPEN MEETING LAW COMMITTEE; A. Report made by Chair Michelle AG to move report on advisory committees to 2024.

- B. Executive session training held on 10-19-23 and well attended. We will be doing more. Copy of recording available under education on web page.
- C. We are working on a letter from the Coalition to contact 177 towns identified in our report that do not allow public comment. We are also working with Assemblyperson Woerner to create a law to mandate public comments. Shocking that 177 towns across NYS do not guarantee right to speak at public meeting ...may or may not allow or deny. This is not the case in several other States in USA.
- D. Working on a training session regarding livestreaming/hybrid meetings **FOIL COMMITTEE**; Report by Chair Maria T.

A. that we are finishing up report with Annmarie and volunteers who have done a tremendous job with 70 FOIL requests, 59 responded to, 6 denied and 5 pending and none appealed. Report to be released in Jan., 2024. Information completed now on excel spread sheet.

B. Article 78 training done on sept., 21 at noon by Mike Higgins with 44 people registered. There is an audio recording available and a 14 page step by step guide. It is recommended to be done with an attorney and may be done independently with at least a probable 350 dollar filing fee. There are possible FOIL training sessions in 2024.

PUBLIC RELATIONS/EDUCATION COMMITTEE; Report made by Chair Axel E.

A. with the Committee working on legislative plan /strategy for getting our legislative bills passed in Albany. We are looking at mailchimp for emailing for about 17 dollars a month to make things easier and trackable.

- B. Albany meeting Sat. Nov., 18^{th} 1 to 6:30 pm at the Hampton INN in downtown. There will be a zoom connection with questions possible. 15 are registered now.
- C. Cards for the Coalition will be handed out so members can identify themselves and qr code for downloading handbook. Motion made by Axel to order 1000 for about 60 dollars of these cards and seconded by Michelle. Motion carried.
- D. Membership fees now at 20 dollars per anum. Suggestion has been made to raise dues to 40 dollars in 2024 and by laws require 10 day notice. Discussion held re pro and con for doing increase with look at tier privileges and survey. Students high school and college could be free membership.
- E. We are working on our Naughty and Nice list to be released in Dec. press conference to highlight people who have done some good and bad transparency things. The suggestion is made to have repeat offenders on list with criteria.
- F. Our Committee recommends reconsidering that the Board have the Coalition be a plaintiff in an Article 78 lawsuit against the City of Buffalo regarding various legal violations when enacting a pay raise for elected officials. See attached overview on page 17 of agenda. In 2021, the Open Meetings Law was amended to change the definition of what constitutes a public body subject to the law. This lawsuit could result in new legal precedent as to what advisory bodies perform a necessary government function, subjecting them to the Open Meetings Law. Michelle made motion for our Coalition to support this new Article 78 lawsuit as plaintiff and seconded by Maria T. Discussion had about getting others to support this and other lawsuits through fundraising. Motion carried.

AMHERST WOMEN'S REPUBLICAN CLUB MEETING 11-28-23; We got an invitation to have someone speak and Annmarie and Maria will be speaking.

CORNELL HIGH ROAD FELLOW APPLICATION; We applied for this last year for student intern free of charge for video taping members the story of why open government is important to them.

Meeting called to order by the Co-Chair, Robyn – No Quorum – 6:32 pm Members present: Robyn, Michelle, Ken, Pat, Stuart, Christine, Linda, Darlene and Annmarie.

- 1. Unable to approve the October 19, 2023 meeting minutes. (Add to December 21, 2023 meeting.) No corrections on minutes.
- 2. Report regarding public comments at meetings
 - a. Robyn created the draft letter after input from members. Do we want to put in links or attach the report directly to the email? Annmarie suggested the link.

Meeting called to order at 6:34 pm by the Chair: Axel

Members in attendance: Axel, Ken, Paul, Maria, Sue, Janet, Pat, Stuart, Susan, Courtney and Annmarie

- 1. Approval of Minutes November 2, 2023 Motion by Paul, seconded by Annmarie. All in favor. None opposed. Motion carried. (Draft minutes attached with Agenda.)
- 2. Revisiting Article 78 lawsuit against the City of Buffalo request for filing fees, \$305.00.
 - a. Paul provided an overview of the cost associated with filing.
 - b. Axel said we should routinely be clear on the cost for future litigations.

Motion by Annmarie and seconded by Maria to recommend that the board pay the \$305.00 for the Article 78 lawsuit against the City of Buffalo for the filing fees. All in favor. None opposed. Motion carried.

- 3. Review of Albany meeting Pros and cons as to how it went. (Meeting notes were attached with agenda.)
 - a. Annmarie thought it was a productive meeting. She thanked Axel, Ken and Robyn for all their hard work.
 - b. Axel also agreed with Annmarie. There was a lot of substance and it was a better meeting than the first one. It is money well spent, but we may want a working group for fundraising and grants in the future.

Motion Axel and seconded by Annmarie that we recommend to the board that we create a working group dedicated to researching for fundraising/grants, etc., of which their findings will be reported to the PR and Education Group Committee who can make recommendations to the board. All in favor. None opposed. Motion carried. A discussion took place prior to voting.

- c. Axel and Annmarie provided an overview of details for a dedicated group of people that would meet outside of the regular committee meetings and bring this back to the PR committee. This would be informal and may require more meetings than a monthly meeting.
- d. Courtney concurred and addressed fundraisers in more detail. Should be less formal.
- e. Axel addressed not having funds for the things we want to do.
- f. Maria said to offer the opportunity to all the members. This working group should determine when they will meet.

- 4. Coalition Membership Fee January is when memberships dues are do. Should we increase the amount of our yearly dues? If so, what amount? (Survey results were attached with agenda.)
 - a. Axel provided an overview and addressed the survey. We should just make it \$35.
 - b. Paul suggested \$30 because all who voted for \$40 would be okay with \$30.
 - c. Annmarie provided a comparison of different amounts and the total amount that we would receive based on current membership. She also agreed with the \$30.
 - d. Courtney said \$30 is okay but what accommodations do we make for those with a low income.
 - e. Axel informed that students are free. Provided additional information.
 - f. Maria says it should be \$35 and explained. Maria said we should look at a donation button.
 - g. Courtney agreed with Maria that we should have a donate button.
 - h. Axel provide further information regarding donations and a donate button.
 - Janet provided detailed information on our current company for donations. Janet informed that the bylaws will need to be updated if we change the dues.
 - j. Pat questioned if members have enough notice. When are they due? Paul January.
 - k. Several members continued to discuss this issue.
 - Susan said we need to clear up our donation page to separate donations and membership fees. Axel said this has been changed.

Motion by Paul and seconded by Axel that we recommend to the board that we increase the membership dues to \$30.00. All in favor. None opposed. Motion carried.

- 5. What process should we use for board positions? Paul provided detailed information about how the board created a self-perpetuating board. There is no membership vote. Currently we have a 13-member board but can expand to 15 members. Paul detailed how selection of board members and officials are determined. There are currently two vacancies. Paul addressed the process. He thought that maybe we should form a nominating committee of three board members who are not currently up for reappointment. He explained how this would work and what happens when they get more applications than there are vacancies.
 - a. Annmarie asked when the voting occurs for board members? Paul stated that was January. Paul provided additional detail.
 - b. Courtney asked if Paul had any candidates in mind for the nominating committee? Paul said they must be current board members that are not up for re-election.
 - c. Axel thinks this is a good idea and explained.

Motion by Paul and seconded by Janet that we recommend to the board that they form a nominating committee of three board members who are not currently up for reappointment to review interested board member applications and they will make a recommendation to the full

board at the January meeting. All in favor except for one abstention by Courtney. Motion carried. (Questions were asked prior to the motion and after the motion.)

- d. Maria asked if current board members need to submit a letter? Paul said yes.
- e. Courtney should this be a trial?
- f. Annmarie asked if the bylaws would need to be updated?
- 6. Naughty and Nice List Axel and Paul provided an overview of this list. This should be held during the season December.

Paul asked when in December to release the list?

- a. Courtney agreed with the release being in December.
- b. Paul better to do it during the day. (press conference)
- c. A discussion occurred by several members as to what time of the day this should occur 11 am on December 14, 2023 was determined to be the best time and date.
- d. Axel addressed the recording of the meeting with further details. Also addressed using Mailchimp and explained what this is.
- e. Maria asked how the list is determined? Paul explained.
- f. A discussion occurred regarding platforms and where else to release it. Courtney provided some areas for posting.

- 8. Website Updates Axel provided updates on our new website and areas that are also being expanded. This requires a lot of time.
- 9. Google Ads grant application Axel provided information on this grant.
- 10. Legislative Action Plan Axel informed that 12 people are interested in doing two days. 13 are interested. Axel will check for any further responses. 15 people would be good. It would be good to run an educational session. This is commonly done. Axel elaborated on other events for those days and Paul is assisting with this. A further discussion occurred with several members on the details of the plan and what we need to do in advance. More discussions will occur at the next meeting once we have the numbers of people interested.

Motion by Ken and seconded by Courtney that the board review our bylaws for correctness and get rid of any conflicting information. All in favor. Motion carried.

Open Meetings Law Recommendations for 2024 Legislative Session

December 1, 2023

New Yorkers learned a great deal during the COVID-19 pandemic, including that remote (and subsequently recorded) public meetings were a boon to members of the disabled community, parents of young children and the many other civic-minded people whose circumstances make it challenging to attend government meetings in person. In the FY 2022-2023 budget, the State Legislature and Governor made many of the COVID-era remote meetings practices permanent, and provided a framework for remote and in-person participation, but did not fully embrace a hybrid mandate.

Fortunately, New York can have both in-person and remote access to public meetings. Agencies like the Metropolitan Transportation Authority (MTA) have shown that a hybrid public meeting process is workable, both for public officials and members of the public that wish to watch meetings, or provide public comment.

Our groups have eight recommendations for how the state can amend the Open Meetings Law in 2024 to require hybrid meetings and close loopholes (updated from many of our groups' <u>March 2022 recommendations</u>):

- Require all state and local public bodies currently subject to OML to provide free, unrestricted remote video and voice access to the public for all their public meetings, including via telephone, using web-based video conferencing applications.
- 2. Where bodies allow or are required to take public comment such as hearings or other public meetings require that the public can provide real-time spoken comment either in-person OR remotely, regardless of whether public body members are participating remotely or in-person.



- 3. Require a quorum of members of <u>elected</u> bodies such as the state legislature and local legislatures to be present in person. The current law's limited reasons for participating remotely should be maintained (disability, illness, caregiving responsibilities, or any other significant or unexpected factor or event which precludes the member's physical attendance at such meeting) to allow members to participate and vote remotely, provided that meeting minutes note which members participated remotely.
- 4. At a minimum, require the presiding officer of appointed boards and commissions or non-elected agency or authority personnel to be present in-person for public meetings, while allowing remaining members of the body to participate remotely, including being counted towards a quorum and voting; a reason for participating remotely should still be required to be provided as under current law (disability, illness, caregiving responsibilities, or any other significant or unexpected factor or event which precludes the member's physical attendance at such meeting). Presiding officers should be able to designate an alternate member of the public body to be present in person due to the limited reasons provided above.
- 5. Require public bodies to provide at least one in-person, accessible meeting location that allows the public to attend per the existing requirement in OML. (The previous requirement that all locations must include public access where individual members of the body are remotely participating in the meeting should continue to be repealed.)
- 6. Require NYS Office of Information and Technology Services (ITS) to facilitate use of widely available, low-cost applications that meet federal accessibility guidelines and international standards and eliminate any requirement that web-based video conferencing apps must be hosted on state or local government-controlled or -owned servers. This would allow state and local public bodies to use widely commercially available web applications like Zoom, Google Meet, Microsoft Teams, etc. as long as they meet basic security requirements established by the ITS and follow other requirements for public access. All such meetings must enable closed captioning, which those services provide, and provide an American Sign Language interpreter upon request.
- 7. Remove "to the extent practicable/as is practicable" language throughout OML: in section §103(e) regarding meeting materials, §103(f) regarding broadcasting and streaming meetings, and §104 regarding notice of meetings.
- 8. Amend language on "advisory bodies" to ensure that more advisory bodies are covered by OML, including formally chartered entities with officially delegated duties and organizational attributes of a substantive nature.

Additionally, the following provisions from 2022 and 2023 changes to the Open Meetings Law should be retained:

- 1. Allow members of public bodies with disabilities as defined in section two hundred ninety-two of the executive law to always be able to participate remotely while counting towards a quorum, provided that the public body maintains at least one physical location where the public can attend meetings.
- 2. Require prompt posting and archiving video of meetings, along with meeting materials and minutes: public bodies must publish online replayable recordings of their public meetings within five business days and maintain an archive of publicly available online recordings of their open meetings for at least five years.
