  - C) Governor Hochul signed a new law sponsored by Senator Jessica Ramos and Assemblymember Michelle Solages (S8419-B/A9622-C), requiring Community Advisory Committees formed for Empire State Development projects to meet publicly, provide public notice of meetings, and publish all meeting materials on ESD's website.
