OPEN MEETINGS LAW COMMITTEE; Chair Michelle Allen reported there was interesting participation from Cornell University students who are working on a policy report regarding the live streaming of meetings. We are looking for signatures on petition from elected officials to NOT discuss public business in private. Per Paul Wolf report we are interested in live streaming meetings, with purpose to determine how many local governments are doing livestreaming and to assist others to do so. AnnMarie has created a database of over a thousand communities. The Caucus gap in OML makes a sham of OML Motion made that the Board is in favor of distributing petition by Maria Tisby and seconded by Michelle Allen. Motion carried.

Open Meeting Law Committee

March 16, 2023, via Zoom

Meeting called to order by the Chair, Michelle at 4:02 pm.

Members present: Michelle, Paul, Annmarie, Linda. Also, Caitlin, Maria and Ken arrived after approval of minutes.

- Minutes approved for February 16, 2023. Motion made by Paul and seconded by Annmarie. All were in favor.
- Cornell and NYCOG zoom overview:
 - Paul provided the highlights and informed this committee that:
 - Another group of students will be coming in for summer and fall so the suggestion was to have multiple reports instead of the one big report for this semester.
 - We should be getting an update from the students in a few weeks and then will determine where to go from there.
- Highlights of Sunshine Week
 - Michelle thought it went very well with no hiccups. It was well received with a lot of engagement and discussion.
 - Caitlin requested a recording. Paul stated there would be one available.
 - Paul said there were 45 registrants, which was a good mix of government people, members, reporters and people from all over, including Alaska and North Carolina. It worked well because of the assistance from Michelle who handled the chat questions and Axel who focused on admitting and readmitting people, which allowed Paul to focus on the speaking and answering of questions.
 - Paul already provided a copy of the zoom meeting to all registered participants.
 - Michelle informed us about the multitude of sunshine week presentations all over the country but specifically David Cuillier, former Board President, NFOIC and presently with the Brechner Center. It was a symposium from Americans for Prosperity on the positivity of fixing the broken system. Addressed ephemeral messaging which is the mobile-to-mobile transmission of multimedia messages that automatically disappear from the recipient's screen after the message has been viewed.
 - Paul informed that the NYS Assembly issued a press release that they passed some minor bills as a package in honor of sunshine week. They were very minor technical bills.

- Pledge for Elected Officials about not discussing public business in secret caucus meetings.
 - Paul at last month's OML committee, stated we passed a motion in favor of a pledge petition to draw attention to these caucus meetings. Asking public officials to sign this petition. As a first step forward for them to commit to not discussing public business in caucus meetings and leaving those caucuses for political discussions. This will be emailed to members next week.
 - Caitlin suggested a monthly packet of "asks" for citizens to approach their board or get their elected official to support our specific monthly topics. (Action of the Month) A discussion ensued with examples of how this could work and on what topics.
 - There was a discussion on communications to Town Boards.
- Report on Mandating Public Comment (Public Comment Project 2023)
 - Paul provided an overview the Open Meetings Law doesn't mandate that a
 local government allow for public comment. Most do, but not all. Buffalo
 Common Council, Erie Co. Legislator are examples of those not allowing public
 comment. There are several other states that do allow it. We support
 mandating it. We need a report as a first step. A discussion covered the
 particulars of creating this report.

Updates on enforcement.

Assembly Steck and Senator Liu have introduced a bill to improve getting attorney fees for a FOIL or OML lawsuit. The legislation was drafted by the Coalition.

Legislator Paulin has agreed to sponsor legislation to amend the NY State Constitution by adding an open government right

The NY Attorney General has not responded to emails regarding legislation we drafted to create a mediation program in the AG's office.

Due to conflict of interest by the AG's office on open government matters, Paul believes having independent hearing officers decide FOIL and OML complaints is a better way to go. Such a process would work similar to the hearing process used for property tax assessment hearings. Paul has drafted legislation and will see if we can get a legislator interested.

Aeemblymember Zebrowski and Senator Skoufis have introduced a bill called the Integrity in government act. The bill has some good and bad points.

This bill keeps the current structure of the Committee on Open Government

Gives the Committee the power to hear appeals re FOIL & OML

Pays Committee members \$200 per day to do hearings, which is not realistic for current committee members to do. Using current committee members will probably result in a lot of decisions that the public will not like. The Committee will not be able to handle thousands of appeals.

Appeals have to be done by mail, should be able to electronically file.

Committee has 6 months to render a decision, which is a bit long.

Requires holding a hearing regarding an executive session issue within 72 hours, with a decision in 5 days.

It provides the Committee the power to fine agencies & people \$20 to \$1,000. Individuals can be fined for filing frivolous appeals

Determination to not support so no motion approved.

No new business to discuss

Public Relations and Education Group meeting held April 6, 2023, via Zoom

Meeting called to order at 3:05 pm by the Chair: Axel

Members in attendance: Axel, Maria, Robyn, and Annmarie. Arrived after approval of minutes – Mary Harris.

- Minutes approved for March 2, 2023 Motion by Robyn, seconded by Annmarie. All in favor.
- 2. Sunshine Week (March 12-18, 2023) Discussion on how it went:
 - a. Members commented on how well it was managed by Axel allowing people into zoom and Michelle was answering questions in the chat so our presenter – Paul, could focus on the presentation and verbal questions; a lot of people participated; this was a taped session and each registrant received a copy of the presentation.

Axel pointed out that a newsletter is a good idea and went on to inform of some of the cons. Explained the use of an "unsubscribe" button as well as changes to SPAM policies.

Robyn expressed the pros of using a newsletter and very few cons if any.

Also, a discussion ensued regarding unsolicited audiences.
