Meeting Minutes; Meeting minutes of October 13, 2022 provided with motion to accept made by Maria Tisby and second by Michelle Allen. Motion carried.

Treasurer's Report; Per Janet Vito, we have 80 members (from 26 Counties) with 10-31-22 balance of \$4,542.24 (\$140 in new dues). Board Elections; Our 12 board positions are for 2 year staggered terms. Six seats are up in Jan. 2023. The following board members' terms expire in Jan. 2023: Paul Wolf, Steve Lyle, Suzanne Kelly, Alberta Roman, Mary Lou Cebula and Joe Kissel. All board members except for Joe Kissel have expressed an interest in continuing to serve.

NY Committee on Open Government Letters; 2 letters are included in pages 8 to 12. One suggests The New York Coalition for Open Government Mandate live streaming of local government meetings in their annual report and require State agencies to require state agencies to prepare an annual Freedom of Information report. The other addresses concerns and suggests live streaming of local government meetings be required "to the extent practicable" as law states.

Attorney General Letter; Letter to Attorney General James by Paul Wolf included in agenda pages 13&14 requesting assistance with 2 issues;

- 1. Creation of an Open Gov. Unit to assist the public with Open Meeting Law and Freedom of Information Law issues.
- 2. As part of an Open Gov. Unit, establishing a mediation program to assist the public as an alternative to pursuing litigation.

Paul has a zoom call with AG office sched for next week on this issue...no press conference at this point.

Valley Stream Letter; This letter by Paul Wolf is addressed to Mayor Fare included in agenda pages 15 & 16 regarding our member being demanded to stop recording a village board meeting...a violation of OML. Also addressed was the lack of posting agenda items as required by law. The letter offered to provide OML training and so far no response. Member will talk with a local reporter.

Legislative Priorities; Legislative priorities for 2023 are included in Agenda packet from pages 17 to 25 in detail and are centered on reforms to OML and FOIL laws. This is posted on our web site and elsewhere.

Open Meeting Law Committee; Chair Joe Kissel absent. Paul Wolf reporting on gathering information for report regarding Private Caucus Meetings held by Gov. bodies at the local level is in progress. Also in progress is gathering information for a report reviewing towns across NY State as far as whether meeting documents and minutes are being posted on line. Paul will send out and hold Press Release at end of Nov.

Freedom of Information Law Committee; Report by Chair Maria Tisby re discussion of Town of Vestal issue where police body cam video was not avail. to a member. Also discussed FOIL scorecard/checklist for tracking FOIL appeals.

Public Relations /Education Group; Report by Chair Michelle Allen re proposed non-partisan policy (which is included in agenda on page 27) for board discussion. Someone can run for election, be elected and be on the Board. What a board member does on their own time is not restricted as long as not associating the statements/actions with the Coalition.

A motion was made by Steve Lyle to accept policy and seconded by Michelle Allen. Motion passed 6-3 with Pat Irving, Janet Vito and Larry Vito being opposed.

Also discussed was forming Regional Advisory Councils; For first formation, a group around Albany is suggested. A training on zoom is proposed for Jan 26 for people participating in Albany area.

New Business; Our Canandaigua meeting face to face was a big success. An internal list serve program is being explored to reduce and make amount and style of notification of emails individualized.
