### Open Meetings Law Committee; Report by Michelle Allen as follows;

- A. Report to support amending the Open Meetings Law to mandate that public comments occur at meetings to be released in Sept. perhaps 14<sup>th</sup> in a press conference. Paul states that in NYS, Citizens do not have the legal right to speak at public meetings.
- B. Our next report will be seeking to have advisory committees created by Public Bodies covered by the Open Meetings Law, which is the case in 31 States. The only recourse now is to file a law suit.
- C. We will be doing a training on executive sessions in October, tentatively 12<sup>th</sup>. We are seeking member input about content. The most common questions received are about executive sessions.

**Freedom of Information Law Committee;** Maria Tisby report as follows;

A. FOIL project regarding state agencies tracking FOIL requests ongoing.

- B. Article 78 training set for Sept. 21<sup>st</sup> at 12:00. Local Buffalo Attorney Mike Higgins has agreed to do this.
- C. Legislation utilizing a Hearing Officer System similar to Tax Assessment casesintroduced by Assemblymember Rosenthal.
- D. Legislation requiring state Agencies to track FOIL requests-Assemblymember Epstein and Senator Hoylman have agreed to sponsor.

# **Public Relations/ Education Committee;** Axel Ebermann reporting as follows;

- A. Committee is working on an open government booklet that can be distributed to public electronically and physically. The document will provide a brief overview of FOIL and OML, which will be helpful to the public.
- B. The Committee recommends that the Board consider having a co-chair designated for each committee. This discussion led by Paul Wolf. Michelle Allen made motion to have co-chair for committee and Axell Eberman second. Motion carried. If anyone wants to co-chair, notify Paul and we will talk about this at next meeting.
- C. Axel Ebermann is working on a new Coalition website, which is not ready to be previewed yet.
- D. Paul Wolf discussed the Committee working on lobbying plan for getting our legislative bills passed in Albany.
